| 4. An Officer of the tribal welfare department in charge of the sub-division or where such officer is not available the Officer in charge of the Tribal Affairs | -Member Secretary |

Notification for constituting Sub-Divisional Level Committee as per the composition prescribed above in terms of section 5 of the aforesaid Rules with names of members shall be issued by the respective Dy. Commissioners forthwith.

The functions of the Sub Divisional level Committee shall be as prescribed in the relevant sections/sub-sections of the aforesaid Act and Rules.

The procedure for formation of Gram Sabha under the Act has been prescribed in section 3 of the aforesaid rules and accordingly the Gram Panchayat shall form Gram Sabhas and inform the Sub-divisional level Committee for implementation of the provisions of the aforesaid Act.
